IN 2014, WE CARED FOR AND ADOPTED OUT OVER 1600 ANIMALS. THESE ANIMALS WERE RESCUED FROM OUR COUNTY ANIMAL CONTROL, HOARDERS, PUPPY MILLS, OWNER SURRENDERS AND OUT OF COUNTY AND STATE TRANSFERS. WE ALSO OFFER A RETAIL DEPARTMENT FOR THE NEEDS OF OUR ADOPTERS.

EACH PET IS ALSO SPAY/NEUTERED, DEWORMED, MICRO-CHIPPED, PROVIDED ALL REQUIRED VACCINATIONS AND MONTHLY PREVENTATIVE. DURING THEIR STAY, THEY ARE FED AND HOUSED IN A CLIMATE CONTROLLED ENVIRONMENT.
