THE CLINIC IS A FULL SERVICE FACILITY OPEN TO THE PUBLIC WITH NO INCOME REQUIREMENTS. THE CLINIC PROVIDES SERVICES RANGING FROM DENTISTRY TO DIAGNOSTIC TESTING TO SURGERY.

OUR KENNELS CAN HOUSE UP TO 160 ANIMALS AT ANY GIVEN TIME. EACH ANIMAL IN OUR SHELTER IS GIVEN A COMPREHENSIVE MEDICAL EXAM AND ANY NECESSARY TREATMENT PRIOR TO ADOPTION. EACH PET IS ALSO SPAY/NEUTERED, DEWORMED, MICRO-CHIPPED, PROVIDED ALL REQUIRED VACCINATIONS AND MONTHLY PREVENTATIVE. DURING THEIR STAY, THEY ARE FED AND HOUSED IN A CLIMATE CONTROLLED ENVIRONMENT. THEY ARE SOCIALIZED DAILY WITH OUR CANINE AND FELINE COACHES.
