THE ANIMAL CLINIC IS A FULL-SERVICE FACILITY AND IS OPEN TO THE PUBLIC. THE ANIMAL CLINIC IS OUTFITTED WITH STATE-OF-THE-ART MEDICAL EQUIPMENT, INCLUDING A DIGITAL XRAY MACHINE, AN ENDOSCOPE, A COLD LASER, AND A BLOODWORK MACHINE CAPABLE OF PRODUCING INSTANT DIAGNOSTIC RESULTS. THE QUALITY OF CARE IS EQUIVALENT TO ANY PRIVATE VETERINARY PRACTICE, AT A FRACTION OF THE COST. ALL PROCEEDS FROM THE ANIMAL CLINIC BENEFIT THE SHELTER PETS AT THE HUMANE SOCIETY OF SARASOTA COUNTY.
